New Business

- David Matta, BWO Insurance here to answer questions. (**Secura Insurance**)
These were the 10 questions submitted for David to answer. **His answers are in bold.**
 1. Do you have attorneys or advisors that can help with our liability waivers to make them as solid as possible? **Yes.**
 - a. Are the liability waivers we have people sign any good? **Yes, they are good.**
 2. Are there any other steps you would advise us to take to further protect the club? **David will have to get back with the club on loss control.**
 3. If a member is teaching a class does our insurance cover them? **Yes.**
 - a. Should members sign a waiver when a class is taught or is their membership good enough? **Yes, sign the waiver for that class.**
 - b. If non-members are in the class, should they sign an additional waiver or is our guest waiver good enough? **They need to sign the waiver as well.**
 - c. If a non-member is teaching a class what does their insurance coverage need to be? **They would need to have a certificate of insurance, a Waiver or a Club add-on.**

4. Some disciplines have their own liability waiver for shoots. Should we have them be universal? **Not necessary, unless the club decides to do so.**
 - a. Do they need them? **Yes.**
 - b. If holster draw is allowed, is there a waiver that goes with the training/ qualification. Is that additional waiver needed? If not does it hurt to have one? **It will not hurt to have an additional waiver.**
5. If someone has a firearm accident are we liable? **Depends on the situation. For the club to be liable there would have to be negligence on the part of the club with over sight.**
 - a. Are there different degrees of seriousness? **Depends on the specific circumstance.** Someone shooting themselves vs. their barrel blowing up due to ammo malfunction? **No. The club wouldn't be negligent. Unless it is the club's firearm or ammunition, then it is covered.**
6. If a bullet eaves the property are we liable? **Yes. That would be a covered claim.**
7. If the club is sued will we lose our insurance or will the rates be so high we can't afford to remain open? **The fee can be raised 25% or more but must give the club a 60 days' notice. The rates can lower as well over time based on claims or no claims filed and years with company. If it is going to be terminated the club must get 60 days' notice as well.**
8. Is there extra coverage on the board members/ the executive board? **Yes, for anything pertaining to club decisions. (all board members).**
 - a. What does it include?
9. If the grounds keepers or other members on a workday are injured are they covered by the insurance? **Not at all covered – only paid workers.**
 - a. What would the coverage be? **N/A**
 - b. What all does it cover? **N/A**
10. Is the club liable if someone gets sick from food served at the BRC? **Yes, if served or cooked, not for anything ordered from a restaurant or food establishment.**
